- 6. Approval of minutes for the District Meeting and the Executive Session held on December 18th, 2018.
  - Motion made to accept minutes of the District Meeting and the Executive Session held December 18, 2019 by Mike Vohland, second by Michael Carlson.
  - Motion passed unanimously by verbal vote.
- 7. Fire Chief's Reports and Staff:
  - a. Call Summary -
    - Total Calls 215 Fire less than 1% EMS 87% Other 13%
  - b. Operational Reports
    - Mike Vohland thanked Chief Amezaga for the great job on the Employee Appreciation Dinner.
    - i. Equipment, vehicle, station
      - Apparatus summary given to Board.
      - Engine T520 at paint shop to be completed by month end
      - Repeater site near Gold Hill (Vista del Cielo area) with approximately 95% area coverage
      - Have been working with Gila Communications –mapping survey, interference study and secondary test on all peaks for interference. One additional test can be done, but not necessary following the first test.
      - Approximate six month time frame presently working off of Tubac
      - Mike Vohland recommends second test; get it done; tap into power; input investment
        with right equipment, building permits, FCC licensing and temperature controlled
        building. Requested costs of a complete upgraded package.
      - HAM radio towers available for use
    - ii. Training
      - Captain Certification course being attended by Captain Green, Captain Carrillo and Firefighter/CEP Manjarrez. Will be completed mid February
      - HazMat Technician training at Golder Ranch being attended by Jeff Little, Jorge Hernandez and Charles Bradley. Will be completed February 22, 2019.
      - Technical Rescue Training being attended by Nick Quiroga. Training consists of Ropes 1, 2, 3; confined space; EBSS Structural Collapse; Trench Rescue; Swift Water Rescue, Machinery rescue and vehicle extrication. 200 hours of training large scale goal to get all departments on the same page with color coding and phone apps
      - Paramedic Certification Classes being attended by Oscar Berrellez. This is an eleven month program
      - Driver Operator Position testing process to fill 9 positions
      - Driver/Engineer Training testing process to select 3 individuals to attend three month course (April 15<sup>th</sup> through July 16<sup>th</sup>) offered by Tucson Fire in conjunction with PCC – no cost to district due to PCC affiliation
      - RRMFD Company Officer Development Course Program to help educate firefighters on transitioning and testing for the Captain role
      - Live Fire Propane Drill with Night Drill Coverage by Tucson news stations, Nogales newspaper and YouTube link
